PAST CHAIRMAN SPEAKS

My Journey as a Chartered Accountant

I was born in the small and quiet town of North Lakhimpur into a business family where commerce and enterprise were often second nature. But my father was never the conventional businessman. He ran a modest printing press—not driven by profit, but by passion. I often assisted him, not just with the mundane day-to-day tasks at the press, but also with something that would eventually shape my career: maintaining accounts. From him, I learned how to write a cash book, post ledgers, and maintain journals with precision and care. It was a quiet initiation into the world of numbers.



At school, I was a reasonably good student—not always the topper, but curious, consistent, and widely read. I took a keen interest in current affairs and regularly read newspapers and magazines. The real

turning point came after I joined the local commerce college. Quite unexpectedly, my teachers and principal began to see in me the potential of a topper. With the strength of their expectations behind me, I went on to come on top in both the council and university examinations.

Chartered Accountancy felt like the most logical next step. In those days, there was no foundation course—one entered the CA pathway only after graduation. In 1993, I enrolled in the course and simultaneously began my articleship with CA B.K. Rathi. I was the only articled clerk in the firm at the time, which meant that every opportunity—every audit, every assignment, every challenge—was mine to learn from. I made it a point to be regular with my studies and diligent in completing the postal answer sheets, which were our primary learning tool at the time.

I began my professional practice in Guwahati in 1996. A defining moment in my journey came when I had the opportunity to work under Sri Ramesh Prasad Agarwalla, a legendary figure in Income Tax practice in our region. He introduced me to Tribunal Practice—an area that would go on to shape my professional life for many years. His command over the Income Tax Act was extraordinary, matched only by his discipline. Despite his encyclopedic memory, he never gave an opinion without first referring to the Act—what he reverently called "The Bible." That habit left a deep impression on me, and I continue to strive to follow his example: never speak without the support of the law.

Another enriching phase of my journey began with my association with the Guwahati Branch of the ICAI. I served as a Managing Committee Member for two consecutive terms, from 2007-08 to 2012-13. It was a period marked by strong collaboration. A key highlight was the construction of the branch building—a milestone that reflected the unity and commitment of the members. I had the privilege of serving as the Branch Chairman in 2011-12, a role that helped me engage more closely with the fraternity. My involvement with the branch continues to this day. I regularly take sessions for GMCS and Orientation Courses for CA students, allowing me to stay connected with the youth and contribute to their formative professional years. I also occasionally speak on topics of professional interest, particularly in the areas of Income Tax and Auditing.

Looking back, my journey has been one of steady learning and quiet persistence—anchored in the values I learned beside my father's desk, sharpened by mentors like CA B.K. Rathi and the late Sri R.P. Agarwalla, and enriched through my association with the ICAI and the wider CA community. Every balance sheet I sign is not just a financial statement—it is a reminder of the faith, discipline, and diligence that this profession demands and rewards.
