CHAIRPERSON'S MESSAGE

Dear Members of the Branch,

Greetings!!

I hope this newsletter finds you in the best of health and spirits. We had a relaxing month in July for member and student activities, though, Career Counselling activities were at its peak. The Committee of Career Counselling (CCC), ICAI signed an MOU with the Assam State School Education Board (ASSEB) Board on 7th July 2025 for engaging Guwahati Branch (EIRC) to promote Commerce Education in the region along with Counselling for CA Course in State Board Schools in urban as well as rural areas of the State. You would be glad to know that the Guwahati Branch conducted about 11 programs under this initiative in July itself with the support from ASSEB.



July was the month for Annual General Meeting, where the Committee presents before its members the report and financials of the Branch. The presence of newly qualified members and getting introduced with them was a pleasure. ITR filing season has picked up now but we still have time for some more learning on relevant and current topics, and we are going slow and steady in the current month too.

As we all know, the Goods and Services Tax Appellate Tribunal (Procedure) Rules, 2025 have been notified on 24.04.2025 to establish the procedural framework for the functioning of the GST Appellate Tribunal (GSTAT). Assam will have one State Bench at Guwahati to handle GST Appeal cases for Assam with 6 more states of North East and 3 Circular Benches at Aizawl, Agartala and Kohima have been announced. 31 Technical Members and 52 judicial members for various benches have already been appointed in August 2025. The government is working to fully activate the Goods and Services Tax Appellate Tribunal as soon as possible.

Tribunals function like Courts and are not like Chamber pleadings of First appeal or adjudication which most of us are aware of. There is a lot to learn and practice for those who aspire to serve clients in GST by pleading in Tribunal or even advising clients and briefing other consultants for pleading cases. To equip and prepare our members in this professional opportunity coming up, a two days' GSTAT Litigation Conference - SAMEEKSHA is being organized on 22nd - 23rd August 2025 at ICAI Bhawan, Guwahati. A mix of CAs and advocates who have great experience in this field have been invited for deliberating in detail on the subject with practice and feedback with Question & Answer session with Moot Tribunal. Registration details for all events and programs are being shared in WhatsApp groups regularly. Members might have attended moots earlier but the kind of sessions that are planned on previous day to prepare your self for the moot and the practical aspects covered with in depth discussion of rules and procedures prescribed in April 2025 are happening for the first time. Members may kindly refer to the detailed brochure and register at the earliest. All information is being shared in WhatsApp groups regularly!!!

EDITOR'S MESSAGE

Dear Esteemed Members,

I am delighted to present to you the July Edition of our Newsletter.

At the outset, I extend my warm greetings on the occasion of CA Day! The month of July holds a special place in our professional calendar—it begins with the celebration of CA Day and typically marks the peak of Income Tax Return filing season. While schools enjoy their summer break during this time, CAs are usually immersed in meeting the 31st July filing deadline.



However, this year has been a little different. With the extension of the ITR filing due date from 31st July to 15th September, even CAs experienced a "summer break" of sorts. This welcome breather provided an opportunity not only to relax but also to update ourselves on important professional developments, such as the Guidance Note on Financial Statements of Non-Corporate Entities. To further assist members, ICAI has issued a set of FAQs—offering clarity and guidance for the effective implementation of this note from 1st April 2024.

This July, the Committee on Career Counselling (CCC), ICAI, marked a historic milestone by signing its first-ever MoU in India with the Assam State School Education Board. This landmark initiative aims to give new momentum to the ICAI initiative amongst the students to increase awareness and preference for making commerce education popular in Assam and North East as well as encouraging the Chartered Accountancy course for commerce students. Under this MoU, the Guwahati Branch has conducted several career counselling programs across various districts of Assam for Heads of Institutions, details of which can be found in this newsletter as you scroll through the pages.

Another key announcement this month comes from ICAI's Direct Taxes Committee, which has revised the guidelines for tax audits under Section 44AB of the Income-tax Act, effective from 1st April 2026. The current ceiling of 60 tax audit assignments per member will remain unchanged; however, it will now be applied on a per financial year basis, encompassing all audits signed—whether individually or as a partner—without sharing the quota among partners. Notably, audits under Sections 44AE, 44ADA, and 44AD will continue to remain outside this limit.

So, this July, let us take advantage of this rare pause to learn, reflect, and recharge, while keeping ourselves updated with these important professional changes.

The newsletter, just like previous editions, captures the spirit and diversity of our activities, and I hope you enjoy reading it as much as we enjoyed bringing it together for you. We await for your valuable feedback to help us shape future editions our E-Newsletter more engaging, relevant, and valuable for all members.

Wishing you an enriching read and an enjoyable summer!
